CNY Spend & Win Promotion 2026

The CNY Spend & Win Promotion (“**Promotion**”) is run by SPTel Pte Ltd and is subjected to these terms and conditions.

[Updated on 6 Feb 2026: The lion dance visit reward has been fully redeemed. The sure-win voucher reward will be extended till 6 March 2026.]

Eligibility:

1. This Promotion is available from 19 January to ~~6 February 2026~~ (update: 6 March 2026), both days inclusive.
 - a. Customers who sign up for any new service (s) with SPTel with a min. total spend of \$2,000 in combined contract value **by 6 February 2026 (update: 6 March 2026)** will be eligible to claim the following rewards:
 - i. **Sure-Win \$100 gift vouchers** per company Unique Entity Number (UEN)
